France : The study was conducted among a sample of 600 people, representative of employees working in private companies of more than 10 employees in France. The representativeness of the sample was ensured by quota sampling (sex, age, profession, and size of the company).



Germany : The study was conducted among a sample of 602 people, representative of employees working in private companies of more than 10 employees in Germany. The representativeness of the sample was ensured by quota sampling (sex, age, profession, and size of the company).



United Kingdom : The study was conducted among a sample of 602 people, representative of employees working in private companies of more than 10 employees in the United Kingdom. The representativeness of the sample was ensured by quota sampling (sex, age, profession, and size of the company).

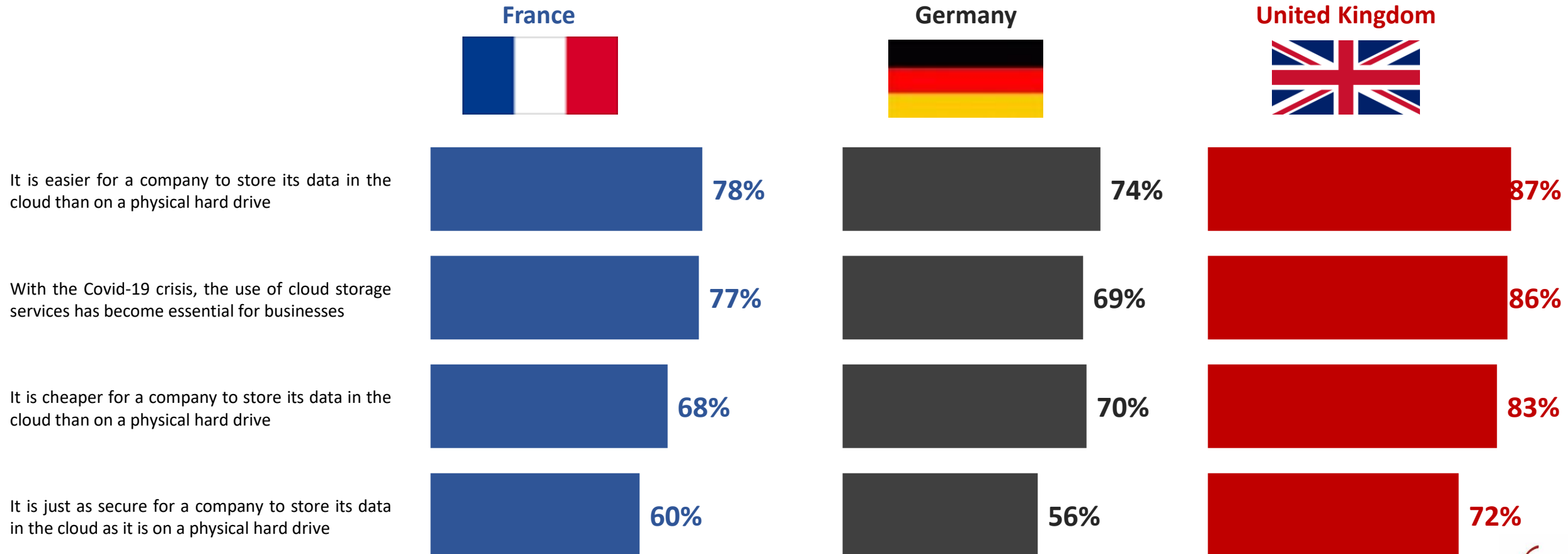

Summary : TOTAL "Agree"

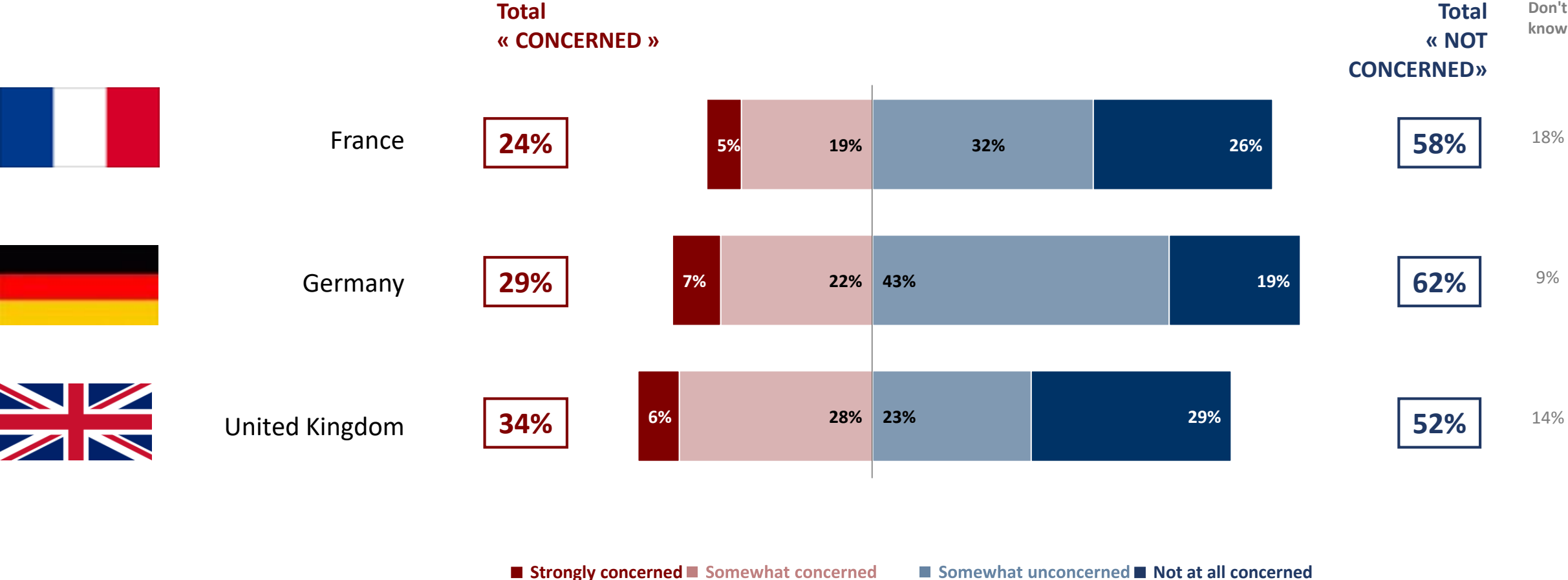
Question : Here are some different statements about the cloud. For each of these, please indicate whether you agree or disagree?

Question : And regarding your company's data, are you concerned about your company storing its data in the cloud?

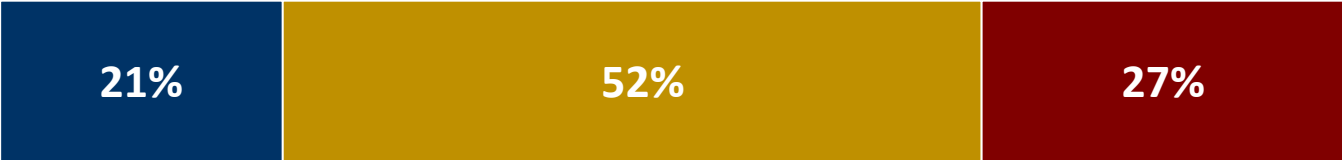


Judgment about the security of data's storage in the cloud compared to physical servers

Question : And would you say that it is just as safe for your company to store its data in the cloud as on physical servers?



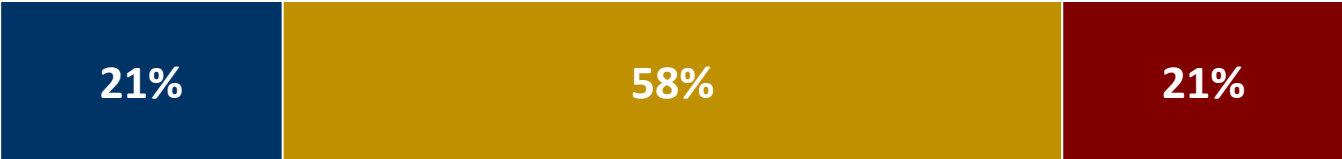

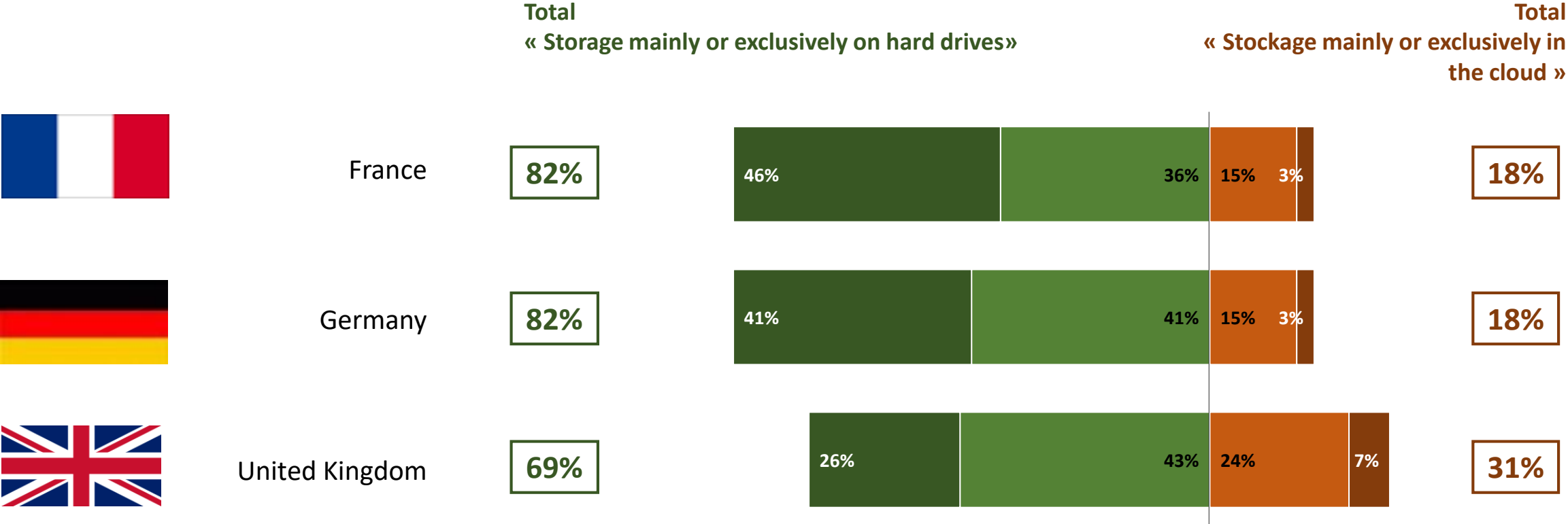

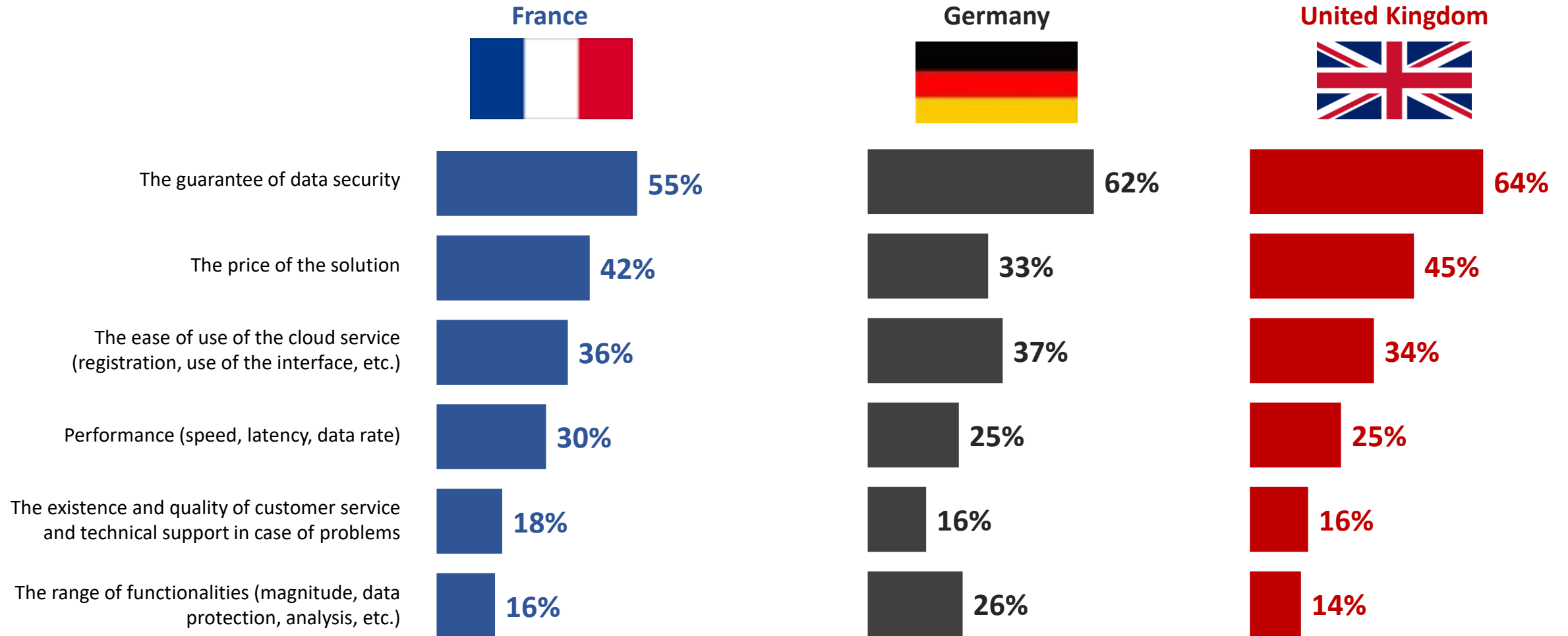

Question : Which of the following criteria do you consider most important when choosing a solution for storing your personal or business data via a cloud service?

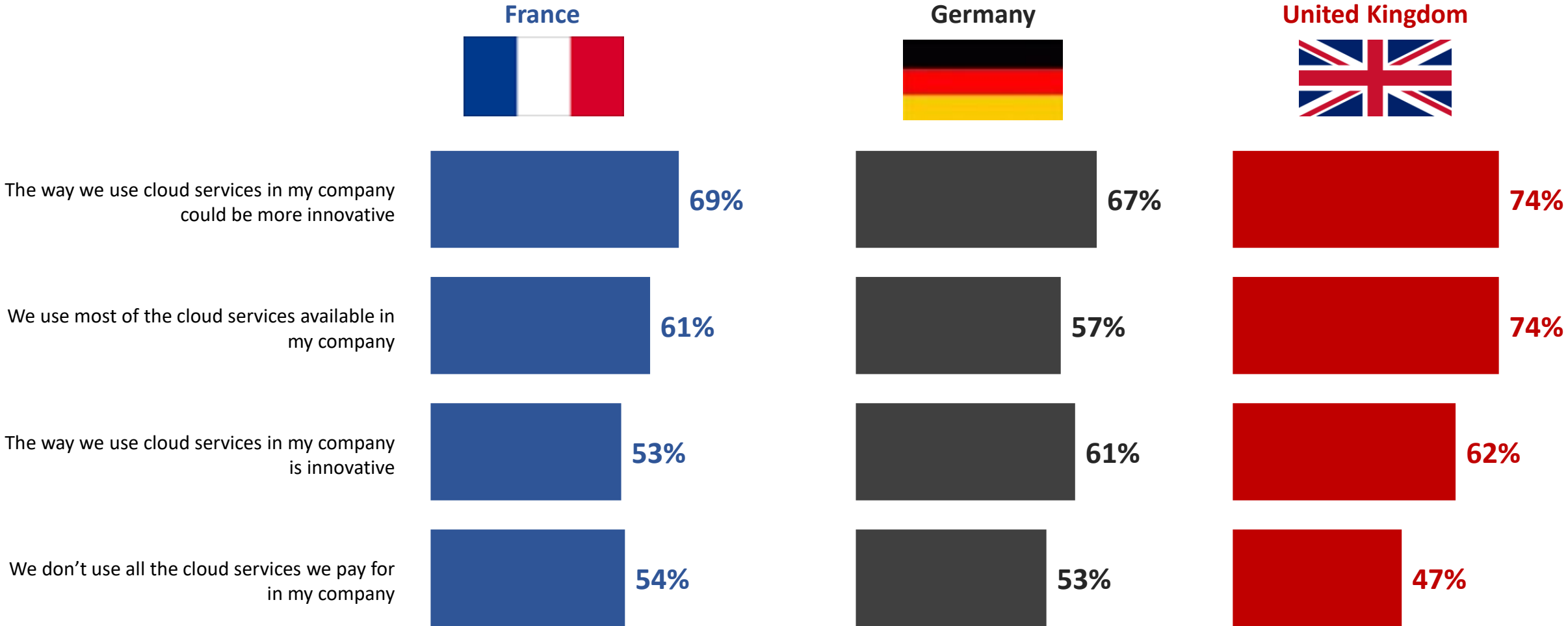
